

Afterschool on the Greenway 2024-2025 Quick Reference Guide

Afterschool on the Greenway (AOTG) offers your child fun, unique experiences that you won't find elsewhere in Fort Mill. We are excited to have your child with us each afternoon to breathe in fresh air and explore the great outdoors. The Hampton Wildlife Fund Adventure Center is a safe place for your child to connect with and learn about the Anne Springs Close Greenway. We encourage environmental stewardship, recreation, play, socialization, and character development along with an impressive amount of getting outside! We serve children enrolled at Doby's Bridge, River Trail, Fort Mill and Sugar Creek Elementary Schools with transportation provided by Greenway and FMSD buses. Our program is run by carefully selected afterschool professionals who offer your child the best experiences both indoors and outdoors. We maintain a low ratio to be sure children are always well-supervised.

Registration Fees & Weekly Tuition

Annual Non-Refundable Registration Fee: \$100 due at the time of enrollment. Weekly Tuition: \$105 a week for Greenway non-members. Tuition is a flat rate billed weekly. We do not prorate for days off regardless of attendance or charge extra for full / half days / early dismissal Days. We provide a 5% discount on weekly tuition for Greenway family membership holders.
